



Fluorescent emergency ballast, hazardous locations

Application

The BHD94GU Universal Input emergency ballast works in conjunction with an AC ballast to convert fluorescent fixtures into emergency lighting. The emergency ballast handles a wide range of input voltages and frequencies and consists of a high-temperature nickelcadmium battery, charger, hermetically sealed relays and electronic circuitry in one compact red case. The BHD94GU can be used with one 18 - 42 W (4-pin) twin, quad or triple twin-tube compact. It is also compatible with one-, two-, three- and four-lamp electronic, standard, energy-saving and dimming AC ballasts. If used in an emergency-only fixture, no AC ballast is necessary. The BHD94GU is UL Component Recognized for factory installation only and is suitable for use in Class I, Division II type fixtures. It is suitable for indoor and damp locations and for sealed & gasketed fixtures, including fixtures rated for wet locations. These fixtures should be tested by the fixture manufacturer in accordance to the standards pertaining to Class I, Division Il applications. This unit is not suitable for air handling heated air outlets. For information about specific lamp and ballast compatibility, please call the factory. Recommended applications include: hazardous locations; line voltages from 120 - 277 VAC (50 or 60 Hz); drilling rigs where generators are the primary source of power; and other applications requiring higher tolerance of line voltage variation or harmonic distortion.

Operation

When AC power fails, the BHD94GU immediately switches to the emergency mode, operating one

lamp at a reduced lumen output for a minimum of 90 minutes. When AC power is restored, the emergency ballast automatically returns to the charging mode and, using a patented circuit, delays AC ballast operation for approximately three seconds to prevent false tripping of the AC ballast end-of-lamp-life shutdown circuits.

Installation

The BHD94GU does not affect normal fixture operation and may be used with either a switched or unswitched fixture. If a switched fixture is used, an unswitched hot must be connected to the emergency ballast. The emergency ballast must be fed from the same branch circuit as the AC ballast. The BHD94GU may be installed inside or on top of the fixture. Installation is not recommended with fixtures where the ambienttemperature may fall below 0°C. Please note: Testswitch supplied is not rated for hazardous locations.

Emergency Illumination

Depending on the wattage and type of lamp selected, the BHD94GU produces 300 to 750 lumens initial emergency light output (see Table 1). During emergency operation, one lamp is illuminated, even if installed with a multi-lamp AC ballast.

Emergency lighting shall be provided by using a hazardous location fluorescent fixture equipped with a Bodine BHD94GU emergency

ballast. The emergency ballast shall consist of a hightemperature, maintenance-free nickelcadmium battery, charger and electronic circuitry contained in one 9 3/8" x 2 3/8" x 1 1/2" red metal case. A test/ monitor plate with a solidstate charging indicator light to monitor the charger and battery, a single-pole test switch and installationhardware shall be provided. The emergency ballast, using a patented circuit, shall delay AC ballast operation for approximately 3 seconds to prevent false tripping of AC ballast end-of-lamp-life shutdown circuits. The emergency ballast shall be capable of operating one _____ fluorescent lamp at _____lumens (see Table 1) initial light output in the emergency mode for a minimum of 90 minutes. It shall be suitable for indoor and damp locations and for sealed & gasketed fixtures it shall be suitable for use in Class I, Division II type fixtures. The BHD94GU shall have 4.0 Watts of input power and a 14.4 Watt-hour battery capacity and shall comply with emergency standards set forth by the current NEC and CEC. The emergency ballast shall be UL Component Recognized for factory installation with a hazardous location fixture.

Warranty
